



Reflect, Update and Affirm Board Goals (May 2024)

- Grow our members
 - Target regions for chapter development such as the northeast (and leverage partnerships)

• Grow our endowment

- Address the service cost gap based on BT cost write offs in 2023
- Grow our engagement (to address the needs of our members)
 - How do we have "reach" into Hispanic related needs and interests?
 - Clearly define committee and subcommittee chair roles (to meet objectives and deliver results)
 - Grow our service to communities

• Grow lifelong memberships

- Return LGHN's value to members to avoid losing members as they grow
- Own our value, mission, goals, programs and services
 - Offer LGHN midcareer certification
 - *Tell our story*... develop consistent clear messaging about history, value, program and services

• Grow high performing partnerships

• Regularly place an LGHN member on the ICMA board of directors (*but do not focus on riding on their coattails*) and guidance to our members about committee nomination and participation

Treasurer's Purpose, Role and Responsibilities

Purpose of the Treasurer

- Provide an *independent* review of LGHN monthly expenses, revenues and payment processing along with receipts.
- An additional level of review.

Treasurer's Governance Role

- Reports to the board's Special Committee to ensure financial integrity of the association's practices. However, the Treasurer is not a member of the board of directors.
- Collaborates with staff to clarify and correct financial reports.

Treasurer Responsibilities

- Review monthly list of expenses/invoices along with revenue receipts.
- Review the monthly summary of financial statements (budget/actual statement and status of bank accounts including *short-term* chapter holdings) in preparation for board meetings.
- May offer thoughts related to governance level financial policies and/or best practices.

LGHN President's Creation and Appointment of the Special Committee for the Treasurer President's Appointment to the Special Committee for the Treasurer

Bylaws provides for the creation in Article 6, Section 3.

Members include Executive Director, Treasurer, Past President, President and President Elect (quorum will require two of the three members of the board).

Special Committee for the Treasurer's *Role* Treasurer reports to the committee monthly including a summary of its review and is not a member of the board of directors as noted above. The purpose of the review is to ensure an additional level of review and independence.
